Within 30 days of trial using or before the license code is provided from your purchase, return the software, the software package and all other items in the package to the location where you acquired it for a full refund. If the software ins bundled with another product, you may return the entire unused product for a full refund.

### **1. GRANT OF LICENSE**

#### **1.1 License Grant**

Gstarsoft grants you the non-exclusive, non-sub licensable, limited license to Use one license of the Software Product on a single computer, subject to the terms and conditions of this License Agreement. The "Use" means installing, loading, running or displaying the software. You are unable to modify the software or disable any licensing or the control features.

#### **1.2 Stand-alone Version**

You may Install and Access a copy of the Software on an individual Computer, which may not be connected to a network in a manner that allows more than one user to Access, upload, operate, view or otherwise create or use a copy of the Software. You may not Install or Access the Software on another computer at a time.

#### **1.3 Network Version**

You may Install, Access and use a copy of the Software on a storage device, such as a network server, for Using the Software Product on Your computers only over an internal network.
